ACMA condition precedent satisfied

Seven West Media Limited (**ASX: SWM**) notes that today the Australian Communications and Media Authority (**ACMA**) has provided written approval under section 61AJ(4) of the *Broadcasting Services Act 1992* (Cth) in respect of the proposed acquisition of SWM by Southern Cross Media Group Limited (**ASX: SXL**) by way of scheme of arrangement (**Scheme**). The ACMA's approval satisfies the ACMA Condition Precedent in clause 3.1(a)(2) of the Scheme Implementation Deed dated 30 September 2025.

Following satisfaction of the ACMA Condition Precedent, all the regulatory approval conditions precedent under clause 3.1(a) of the Scheme Implementation Deed have now been satisfied.

The Scheme Meeting will be held at 10:00am (Sydney time) at Level 6, 8 Central Ave, Eveleigh NSW 2015 on 22 December 2025.

The Scheme remains subject to the satisfaction of other remaining customary conditions as set out in the Scheme Booklet in relation to the Scheme, which was released to ASX on Wednesday, 12 November 2025. SWM shareholders are encouraged to read the Scheme Booklet in full.
